II. GRANT REPORTS
NJSCA (New Jersey State Council on the Arts)

Commissioner Drake briefly mentioned the 2012 NJSCA projects and reported that the NJSCA long term plan was in progress, although not due until the end of 2012. Staff reminded the Commission that all 2013 projects that required County participation have to support or relate to the County Tri-Centennial.

NJHC (New Jersey Historical Commission)

Commissioner Drake indicated the draft Long Range Plan was available for review and would be submitted with the NJHC Final Report. Chair Stevens indicated that the Long Range Plan was complete and has already been submitted to the State. Chair Stevens further indicated that the Arts Plan due to the State will follow the same format. Commissioner Drake further spoke about some of the NJCH projects, and an additional update on the Expo. There was a general discussion on the County budget process. No formal action was taken.

Kids Kulture: Commissioner Jones reported there will be no further reports until the fall.

Art Show: Commissioners Hunt, Jones & Drake confirmed that the planning for the art show was going well, with a number of details to completed without the benefit of an August Commission meeting. Staff will prepare a schedule for the gallery minders.

Sites of Historic Interest: Chair Stevens reported that she is continuing to work with a Tewksbury, Readington and Lebanon Township on their contributions. The project continues to move forward, slowly. Patty Liedner has been putting time to get all the data in a format for publishing.

Roads of Home:

Commissioner Curcio shared some historical tidbits from his research and his favorite bar in Trenton. He further indicated there were no other material updates, but the book should be ready in 2013.

Hunterdon's Civil War Vets: Commissioner Kuhl indicated that the book is complete and ready to be printed when the formatting logistics are complete and after the Fair when the print shop has more time.

300th Anniversary of the County: Commissioners Kuhl and Jones reported there are no material updates. There will be a poster from the Committee looking for volunteers for the 300th Committee. They did indicate that the September meeting will focus on fundraising.
