IV. COMMISSION PROJECTS

Arts

Kids Kulture:

Commissioner Jones reported that Kids Kulture has 2 shows scheduled at Immaculate Conception School with Arithratickles on November the 12th for \$1440.00 and Franklin Township wanted Mayhem Points for \$1200.00. Delaware Township wanted Pushcart Players doing "Celebrating NJ "for the 350th celebration. There is \$1160.00 left over. The \$950.00 has been approved from the state to roll over with an ending balance of \$210.00

Art Goes to School:

Chair Stevens reported that AGTS has a meeting scheduled on November 20th 2013. Letters were sent this year to the Principles <u>and</u> to the art and enrichment teachers. There has been a greater response and the schools are calling in to make arrangements.

<u>Art Show 2014</u> – Kids Photos-Interpreting Hunterdon History: Commissioner Jones reported that from the middle of May until the end of June the auditorium-kitchen side has been reserved. She has been looking into renting the panels for the art show. The panels have a rental price of \$765.00. They are first come first serve, we would need 30. The commission would need to agree on the charge and a pickup in Lancaster County. All grade levels will be accepted. The \$210.00 left over will be used to purchase foam core so that the photos are of standard size. Next is getting the schools involved. Commissioner Jones has compiled a list of school contacts to start the process.

History & Preservation

Site Signs:

Chair Kuhl reported that Marilyn Cummings sign has been put on hold due to issues with credibility of the information. Nine signs are being produced. Scott Fernandes at Award Signs said that the signs should be completed soon. Chair Stevens stated that Skylar Harris from the state said that the signs are to "wordy" and people driving by have a hard time reading the signs, that we need too simplify the signs.

V. NEW BUSINESS

Facebook Page & Web Page updates and ideas

Staff Susan Holcombe Pena reported that the request is on the November 6th 2013 agenda for the freeholders to discuss the Facebook page. Staff also reported that she has been working on a variety of things that have been listed on the handout. Calendars, Color Me Art projects for the kid's pre-k – 3rd grade, iPhone sites, activity books, etc. Re-vamping the website to be more user friendly and interactive. Staff and commission also have been discussing slides and negatives to discs. Chair Stevens has asked that the films be located to be converted. Paypal was also brought up, and it was asked that we start asking permission since the Historical Society does this also and the benefit of selling the books electronically, E-Books. Staff will investigate. Staff is still looking for a display case for the lobby of building #1. Commissioner Davidson brought about asking the library (Mark Titus, Director) if they can display and possibly sell our books there also. Chair Stevens made a Motion to approve Staff Susan Holcombe-Pena to present ideas to the board of freeholders as directed by the Cultural & Heritage Commission. Moved by Curio, Seconded by Kuhl, Motion Carried.

Staff also has brought again the fact that the commission could use a newsletter or a current events letter or a "what's happening newsletter" either via paper or email or Facebook (once the approval has been made for Facebook) Facebook would be the preferred choice since it costs nothing to put out on the web. Email addresses can be obtained, Chair Stevens said. Commission Hewitt said that this is a first step of putting out our "Brand" to the public. Youtube is a thought; Commissioner Hewitt thought that it's wonderful. People look to the web for education and learning, and the comments can be beneficial.
