Parks & Open Space Advisory Committee Meeting Notes of January 19th, 2016

AGENDA 1. POSAC convened on Tuesday January 19th, 2016, at the Route 12 Hunterdon County Complex, Flemington, NJ. The meeting was called to order at 7:02 p.m. by Chair Steeves.

Chair Steeves introduced the Committee and addressed the public in regards to the purpose of the public comment period to address the Open Space Trust Fund Plan. Staff then gave a brief synopsis of the Open Space Trust Fund Plan, the changes that had already been made based on previous comments, and opened the floor for additional comments.

<u>AGENDA 2.</u> Approval of the Nov. 16th, 2015 Meeting notes: Bill Harclerode made a motion to approve the minutes. Jordan Guenther seconded. Motion passed with Renee McNamara abstaining.

AGENDA 3. Review/Final Recommendation Municipal Grant Program Applications

• Raritan Township – debt service: Staff updated the Committee on the fact that more information was needed to be able to act of this application. It is anticipated that the application would be ready for the next meeting in March.

AGENDA 5. Review/Final Recommendation Cooperative Program Applications

• <u>East Amwell Township - Higgins</u> – Staff presented the application from East Amwell Township for an additional cost share toward the acquisition of the Higgins parcel. This request would constitute a total 50% cost share from the County for the purchase. Suzanne Wilder made a motion to approve the application. Bill Harclerode seconded. A roll call vote was taken. Motion passed unanimously.

AGENDA 6. -PARKS OPERATIONAL

Miquin Woods/Lebanon Trail connectivity – Staff presented the proposal by Lebanon Township to connect a Township park to the County's Miquin Woods open space parcels. The Township wishes to get the County's consent before they moved forward with a small acquisition project to connect a Township owned open space parcel with the County park. Renee McNamara made a

Staff will keep the Committee updated as we bring the consultant on board and start the process.
- <u>Nominating Committee</u> The nominating committee recommended Earle Steeves to serve as Committee Chair for 2016 with Jordan Guenther serving as Vice-Chair. Suzanne Wilder made a motion to accept. Bill Harclerode seconded. Motion passed.
