COUNT 1 THEFT BY DECEPTION 2ND DEGREE


The Grand Jurors of the State of New Jersey, for the County of Hunterdon, upon their oaths present that Nicola Stasak, on about or between January 1, 2015 and April 14, 2017, in the Township of Franklin, in the County of Hunterdon, and within the jurisdiction of this Court, did commit theft by deception by purposely obtaining property of Walmart, specifically by adjusting and transmitting fraudulent payroll/time sheets, in order to be paid for time that defendant did not work, in an amount greater than \$75,000, contrary to the provisions of N.J.S.A. 2C:20-4a and N.J.S.A. 2C:20-2b(1)(a) and against the peace of this State, the Government and dignity of the same.

COUNT 2 FORGERY 3RD DEGREE

The Grand Jurors of the State of New Jersey, for the County of Hunterdon, upon their oaths further present that Nicola Stasak, on about or between January 1, 2015 and April 14, 2017, in the Township of Franklin, in the County of Hunterdon, and within the jurisdiction of this Court, with purpose to defraud or injure, knowingly did utter as true to Walmart a writing, that is, fraudulent payroll/time sheets, contrary to the provisions of N.J.S.A. 2C:21-1a(3), and against the peace of this State, the Government and dignity of the same.


COUNT 1 THEFT BY UNLAWFUL TAKING 3RD DEGREE

The Grand Jurors of the State of New Jersey, for the County of Hunterdon, upon their oaths present that Brody B.
