MEDIA RELEASE – OCTOBER 10, 2017 **COUNTY FUGITIVE SWEEP CAPTURES 21 WANTED IN HUNTERDON**

Hunterdon County Prosecutor Anthony P. Kearns, III, and Hunterdon County Sheriff Frederick W. Brown announces the Hunterdon County Joint Fugitive Task Force apprehended twenty fugitives in Hunterdon and surrounding counties, on outstanding warrants. Detectives from the Hunterdon County Prosecutor's Office and Hunterdon County Sheriff's Office successfully teamed with law enforcement officers from several outside agencies, including the New Jersey State Police, the Somerset County Sheriff's Office, Raritan Township Police Department, Readington Township Police Department, Tewksbury Township Police Department, Bridgewater Township Police Department, and Deville Police Department to effectuate the arrests.
