DISCLAIMER

Please be advised that on November 20, 2020, New Jersey passed A-1649, also known as Daniel's law, which exempts access to certain personal information, including but not limited to home address, whether a primary or secondary residence, of active, formerly active, and retired judicial officers, prosecutors, and law enforcement officers, and their family members. The law defines a "judicial officer" as an "active, formerly active, or retired federal, state, county, or municipal judge, including a judge of the Tax Court and any other court of limited jurisdiction established, altered, or abolished by law, a judge of the Office of Administrative Law, a judge of the Division of Workers' Compensation, or any other judge of any other court or who handles proceedings established by law who serves in the executive branch."

At this time, the County is awaiting guidance from the State on implementation and does not have a mechanism for determining whether an address is that of a judicial officer or other covered person as set forth in Daniel's Law. As such, the County is not able to provide you with any address information at this time.
