### **ARREST MADE IN ARMED ROBBERY**

Acting Hunterdon County Prosecutor, Michael Williams announced, “On Thursday, June 20, 2019, Brandon C. Pyzik, age 27 of Flemington, NJ was arrested for an armed robbery that occurred on June 11, 2019. Mr. Pyzik was charged with first degree robbery, fourth degree theft, third degree possession of a weapon for unlawful purpose and fourth degree aggravated assault. The arrest and investigation were conducted by Detective Corporal Scott Iglay and Detective Meg Hammond, Raritan Township Police Department. Detectives for the Hunterdon County Prosecutor’s Office’s Major Crimes Unit also provided assistance.”

Hunterdon County Acting Prosecutor Michael Williams, Chief of Detectives Frank R. Crisologo and Chief Al Payne, Raritan Township Police Department announced a reward has been offered by Hunterdon County Crime Stoppers for the arrest of an Armed Robbery suspect.

According to Acting Prosecutor Williams, "On June 11, 2019 at approximately 7:02PM officers were dispatched to Triton Gas Station located at the intersection of Route 31 and Bartles Corner Road for a report of a robbery. When officers arrived, they learned that an unknown male approached the gas attendant and displayed a knife. While holding the knife on the attendant the suspect reached into the attendant's pocket and removed cash. The suspect fled on foot."

Acting Prosecutor Williams added, "Crime Stoppers of Hunterdon County has offered a cash reward of \$1000 for information that leads to the arrest of the Armed Robbery suspect. I remind our residents, if you see anyone matching that description, do not approach the suspect rather, notify law enforcement immediately. Please remember all tips submitted will be kept anonymous. This investigation is ongoing and police are following several leads.
