ELEVEN ARRESTED IN NARCOTICS INVESTIGATION

Acting Hunterdon County Prosecutor Michael J. Williams and Acting Chief of Detectives Frank R. Crisologo announced the arrest of 11 individuals on narcotics charges.

During the month of October 2019 as part of an ongoing narcotics investigation dubbed "Operation Oxy Klean" targeting the illegal use and distribution of prescription legend drugs in Hunterdon and Warren Counties during 2017 and 2018, members of the Hunterdon County Prosecutor's Office's Narcotics Task Force (HCPO-NTF) charged 11 individuals - Alexandria Peterson, Davey Hendershot, Kevin Merring, Melissa Mace, Michael Bishop, Pierre Demunguia, Sarah Norris, Jessica Croucher, Carlynda Zaro, James Crouse, and Chester Williams - with third degree conspiracy to possess controlled dangerous substances and disorderly persons offenses of possessing prescription legend drugs.

These enforcement actions are the culmination of a long investigation into the use and distribution of illegally obtained Oxycodone and Percocet pain pills throughout Hunterdon and Warren Counties. Prescription monitoring documents and cellphone analysis revealed an ongoing illegal redistribution of thousands of prescription pain pills for street-level consumption. Oxycodone and Percocet, each a Schedule II controlled substance, require a valid physician's prescription along with the medical necessity for the prescribed dosages. Several people arrested in this investigation were obtaining these prescriptions from physicians and nurse practitioners but diverting them for street-level sales.

This investigation is ongoing and is being prosecuted by the Hunterdon County Prosecutor's Office.
