TWO ARRESTED IN CLINTON TOWNSHIP NARCOTICS INVESTIGATION

Acting Hunterdon County Prosecutor Michael J. Williams, Acting Chief of Detectives Frank R. Crisologo and Clinton Township Police Department Officer in Charge Lieutenant Tom DeRosa announced the arrest of two individuals on narcotics charges.

According to Acting Prosecutor Williams, “A joint investigation by the Hunterdon County Prosecutor’s Office’s Narcotics Task Force and the Clinton Township Police Department has led to the arrest of Daniel Weber, age 35, of Westwood, NJ, and Jessica Lodge, age 36, of Paramus, NJ, on January 6, 2020. Mr. Weber was arrested and charged with 3rd degree Possession with Intent to Distribute Xanax, 3rd degree Conspiracy to Distribute, 4th degree Possession of a Substance to Defraud a Drug Test and Possession of Drug Paraphernalia, a disorderly person offense. Mr. Weber was in possession of 422 Xanax pills at the time of his arrest. Ms. Lodge was charged with Possession of Marijuana Under 50 Grams and Possession of Drug Paraphernalia, both disorderly person offenses.

Mr. Weber and Ms. Lodge were both released on their own recognizance and are due back in Hunterdon County Superior Court for their first court appearance. This investigation is ongoing and is being prosecuted by the Hunterdon County Prosecutor’s Office.

The filing of a criminal complaint is merely a step in the criminal justice process. The defendant is presumed innocent until the matter is resolved in a court of law.
