HUNTERDON COUNTY CRIME STOPPERS OFFERS \$5000 REWARD

Acting Hunterdon County Prosecutor Michael J. Williams, Acting Chief of Detectives Frank Crisologo, and Holland Township Police Chief Sean Gutsick announced that a reward has been offered by Hunterdon County Crime Stoppers for information leading to the arrest of the person(s) responsible for the fatal hit and run motor vehicle accident last night in Holland Township.

According to Acting Prosecutor Williams, "At approximately 5:25 pm on November 16, 2020, members of the Holland Township Police Department were dispatched to County Route 519 in the area of Gridley Circle Road for the report of a body on the shoulder of the roadway. Upon arrival police discovered a deceased male who was later identified as Raymond Levandowski, age 73, of Holland Township. Initial investigation revealed Mr. Levandowski was the victim of a hit and run motor vehicle accident."

Acting Prosecutor Williams continued, "Anyone with information regarding this tragic death is urged to come forward. Crime Stoppers of Hunterdon County has offered a \$5000 reward for information leading to the apprehension of the person responsible for Mr. Levandowski's death. We are grateful to Crime Stoppers of Hunterdon for all their continued support and assistance."
